A little over a year ago most of the world came to a standstill. Schools, restaurants, and non-essential businesses were shut down and the only people allowed to leave their homes were essential workers. All postal employees are considered essential, including rural carriers. So, what did you do? You went to work. You took on the additional risks of possibly contracting COVID-19 or carrying it home to your families. You delivered the mail and the thousands of extra packages brought on by the discovery of on-line shopping by those tucked safely in their homes. It is this type of dedication and loyalty to our customers that has always made me proud to be a part of the rural carrier craft.

The pandemic also caused the cancellation of local and state meetings. The cancellations left us with the funds that would normally be budgeted to cover the expenses for these meetings. Some of these funds were used to purchase neck gaiters (face masks) and mail them out to our members. The money that was budgeted for this years Booster was used to cover the cost of producing a virtual conference instead. The conference was viewed by over 200 members who otherwise may not have had access to the valuable information provided.

We have now "missed" two state conventions and two national conventions. Rather than sit on the money that was budgeted for these events the board has decided it should be rebated back to our hard-working members. Gift cards will be mailed to all members in-good-standing that were on

the rolls as of April 15, 2021. Regular carriers, PTFs, and RCAs will each receive a \$50 gift card and retirees will each receive a \$25 gift card. PLEASE NOTE!!! Some extra scholarships were also funded with this unspent money. Two additional \$500 scholarships were covered by the state and our state auxiliary covered six more. Thank you, Auxiliary! A total of ten scholarships were

awarded.

When the pandemic first began the media would occasionally give a shout-out to various groups of essential workers and often postal workers were left off that list. But you were there. HR 4268

On June 30, 2021, H R 4268 was introduced into the 117th Congress by United States House Representative Derek Kilmer (D- WA 6) and has a co-sponsor in Tom Cole (R-OK 4). Although it is in the first stage of the legislative process, and the exact language has not been formalized, this is the bill to amend title 5, United States Code, to provide that civilian service in a temporary position after December 31,1988 may be creditable service under the federal Employee Retirement System and for other purposes. In layman's terms, this is a reintroduction of the 'Buyback Bill'. This bi-partisan bill could benefit just about every carrier in one way or another. It is a proven fact that representatives listen to their own constituents more than any other form of communication. Your Illinois State Board is looking for carriers to help with this task in each Congressional District. Are you driving your personal vehicle on your route? If so, are you being insured properly?

2020-2021 Annual Report of the Secretary Treasurer

I begin my report by thanking all

of you who have showed up and stepped up to the formidable task of delivering as CO-VID continued to complicate our world.

We are finally in a place where businesses are open with few or

no restrictions in place. COVID infection rates are lowering, and vaccines are plentiful in our State. Inside the world of rural carriers little is, as it was pre-pandemic. Many carriers have seen parcel volumes increase drastically and remain high even as Amazon continues to increase their own delivery service. Many classes of mail have drastically fallen in volume. Leave replacements remain in extremely short supply. The Postal Service continues to use the "fast track hiring process" which is an admitted failure. A limited number of the new Metris vehicles continue to be deployed on rural routes of all types. We now have two Postal Districts in our State instead of four. The NSS has shifted to match the Postal District changes. Steward travel to represent members is limited but is hopefully beginning to open up. Local, State and National meetings were all canceled for the second year in a row. Virtual meetings began in an effort to provide information to our members. Workloads and stress levels are too high, in too many offices.

Recruiting struggled as the hiring process led to many no shows at orientation and academies. The pandemic smaller class sizes and delays in getting through the academy. During the year we processed 748 new active members. Of those 296 have separated or left the rural craft. Of the 125 members who retired 55 joined as retired members. In FY 2019-2020 we managed to be among the few States in positive numbers, ending the year with 4310 members. We end FY 2020-2021 with 4234 members. In preparation for the gift card mailing 30 members were found to be deceased from many years ago. They are part of the 76 members lost during the year.

Embassy Suites worked with us on Convention and Booster cancelations. We were able to move those contracts to 2022 without penalties outside of committing to a board meeting being held at the facility in June if restrictions allowed. The Board has continued to hold both Zoom and in person meetings throughout the year and the June meeting was held. We will try again in 2022 for the Late Winter Booster. It will be held Friday night February 25 & Saturday February 26 of 2022. The Booster and State Convention will be held at the East Peoria Embassy Suites 100 Conference Center Dr. Single and double room rates are \$109, Triple \$119 and \$129 for quad. Breakfast and evening reception is included with the rooms. This centrally located venue is one of the finest hotels we have used in recent years.

Bonding reports were completed in July of 2020, and we have four county units requiring a bond. This is likely to increase, as little or no funds were spent, and we are set to disburse another \$34,184 to local units this fall. Every County unit filed the LM 4 with

the DOL on time. The State audit was completed by an outside accounting firm, and the State's LM 2, 990 and county 990-Ns were also filed on time.

As the pandemic continued in the fall, our Booster planning shifted to virtual. With National's approval to have DR Tracy Panepinto participate, a virtual conference was planned and produced. Seminars on retirement, TSP, contractual information, legislative and more were incorporated. Over two hundred members made use of the seminars which were posted online during March, April, and May. Most participants had not attended in person meetings but found the flexibility of online events worked for them. Other members struggled with the technology. The website development, hosting, studio space, A/V equipment use, and editing services cost the Association \$16,675. This is in line with the costs for hosting an in-person Booster. For many years Booster attendance has hovered around 100, so hitting the 200-participant mark suggests it was a relatively good value to the members.

As meetings were canceled in the

spring of 2021, the NRLCA made the offer that stewards and NRLCA officers would make themselves available for approved Zoom® meetings. These meetings had to be live and could not be recorded for future use. Meeting notices were mailed to members, with three meetings being held on weekday evenings. NRLCA President Ronnie Stutts and NRO Jeanette Dwyer took part along with DR Julia Doggett, giving a lot of information to participants. Although the cost for these meetings was low, less than 100 unique participants took part in these three meetings.

The 2020-2021 FY Statements provided here are unaudited and also incomplete as some of the June bank statements were not released yet.

We will first address the Statement of Financial Position. This is a snapshot of our finances as of June 30, 2021, in comparison to the same date in 2020. You will note that the combined value of our checking, savings and investment CDs are down \$81,970.51. This is due to a purchase of Visa gift cards that were ordered at a cost of \$193,025.

These gift cards will be mailed to members as a dues rebate. Recipients must be members in good standing at the time of the mailing, and as of April 15th, 2021. Fifty-dollar cards will be sent to active members and twentyfive-dollar cards will be sent to retired members. Due to canceled meetings and other savings, the Association had a net income of almost \$24,000 last year and was set on June 28th to end this year with \$116,000 in net income. It is predetermined that the 2021 National Convention is canceled, producing an approximate savings of \$70,000. The State Board determined returning funds to the members in appreciation of their support during the pandemic was appropriate. Gift cards will be mailed in the month of August or September as they arrive. Other specifics may apply as determined by the State Board. In the Liabilities Section you will see Employee benefits payable is 7,377.98. This includes the estimated employer portion and employee funded retirement, health insurance, life insurance and TSP benefits from the 4th quarter. Federal and State withholding tax deposits were made leaving a tax liability of \$532.73. The Lorene Maher and Carol Bowen Scholarship had assets of \$9,409.50 at the beginning of last year and is shown as Temporarily Restricted. This will be adjusted for donations and expenses and will start next year with an unaudited amount of \$7,959.50 with \$700 in funds yet to be paid out for scholarships already awarded.

The Statement of Activities is an overview of funds taken in and spent during the year. Interest rates have decreased, and June interest has not been entered leading to a decrease of \$6,379.57. Membership dues have increased slightly as dues increase with wage increases. There was no Reimbursements or Sales income. These items account for the loss of income of \$12,295.15. In expenses the Incentive account is money paid out for the RAFT program during the period the NRLCA RAFT stopped. Nearly all the RAFT payments were paid to academy trainers. The accounting and legal account had an increase of \$1790.63 which was incurred with \$1,995 in fees to close a VOYA retirement account that was a holdover from the period when the stewards were State employees. The awards account con-

tains the \$193,025 gift card purchase. Training is down as most was done virtually and only when necessary. The employee benefits increase would be due to increases in insurance costs and TSP. Lodging was up \$1,779.35 over the previous year which also saw the convention canceled. The Board and Finance Committee continued holding meetings as necessary. Only a few expenses for the PO Boxes were incurred in the National Convention Account. Office expenses are down substantially as Gaiters purchase for \$21,000 last year, were included in the supplies account in Office Expenses. Per Capita Dues are also down as last year there was a final direct payment to the Auxiliary of \$8,666. Postage increased due to extra mailings including the Gaiters. Printing is down as a printer maintenance contract ended saving about \$1,500. Salaries and wages are down \$2,100 even though there were contractual and COLA increases. This is compared to a year that also saw meetings canceled. Travel was down as inperson meetings were canceled or less frequent. The website is being updated, manuals are being created, and training provided for our webmasters costing \$1,200. Although the year has a loss of \$77,441.85 the multi-year cancelations will provide a savings to offset most, or all of the money distributed back to the members.

During the last year I was assigned to the Big Four, Boone Winnebago, McHenry, Lake, Kane-DuPage-North Cook County units. I attended all of the virtual meetings held and participated in creating the Virtual Conference. I assisted in mailing neck gaiters to our members, supplied materials to orientations and training locations, held virtual trainings as needed for local officers, mailed officer and steward gifts, attended three in person Board meetings and ten virtual meetings. I attended various committee meetings and meetings with the NRLCA Board. I have covered countless remote orientations and academies throughout Illinois and Southern Wisconsin. I have completed my duties as Secretary Treasurer and strive to make improvements in our operations. I have made myself available for carriers in need of assistance on weekends, holidays and outside of normal office hours.

I am honored to serve this Association and its' members. Thank you to my family for their support. I would also like to thank my fellow Officers, County Officers, Committee Members, and members of the Association. Without a team effort we would never achieve our goals.

Convention Report 2021- Illinois 1 & Illinois 2 Districts

To the NRLCA National Board, the Illinois State Board and all the hard working, dedicated Rural Letter Carriers in the Illinois 1 & Illinois 2 Districts, this is the 2021 Convention report from the districts.

This is how the 2020 Lakeland District convention report began.

"Neither snow nor rain nor heat nor gloom of night stays these couriers from the swift completion of their appointed rounds."

In this year of vast uncertainty, the words 'nor pandemic nor riots, violence nor looting', should be added to the Postman's creed. You all have risen to the unprecedented challenge that has befallen us as a country; our world. Your dedication to your customers is seen every day, your presence on your routes in the face of the turmoil, gives everyone a sense of normalcy. Thank you for being the face of the United States Post Office; you all, are doing such a great job.

And this sentiment reigns yet again in the first half of the year 2021.

But there is hope, with multiple vaccines available and better awareness about how COVID-19 is spread, we have hope that although not what we were used to but close to the way we used to live, is getting closer to reality. Stay strong.

Early 2020 things were starting to ramp up for the mapping process of RRECS, and it is only recently that 1000 routes were chosen for the pilot test of this project. At the writing of this article, the deadline of June 11th to have all the test routes mapped has been extended another week to June 18th. NSS Stewards have been welcomed into the pilot offices to observe the procedure as we all look forward to the success of this major event in the making. It was in 2012 when the seeds of the Rural Route Evaluated Compensation System were planted after that contract year arbitration.

Over the last year, NSS Stewards

have held video meetings with management as well as with the membership through Zoom meetings set up by the Illinois state board; we have processed grievances, attended arbitrations, predisciplinary investigative interviews and participated in labor management meetings. We fielded calls, conducted Local Steward Certification trainings, and now will be resuming enhancement trainings, using a hybrid model of in-person and virtual options. We are continuing to make alterations to the way we operate as things open back up.

For the whole of this convention reporting period, we have had to change the way we conduct business, but we continue to persevere. In 2020/2021 there were changes in delivery operations; previously DUOed delivery zones were planned and relocated back to their original office and of course the most current shake-up that prompted the NRLCA to realign NSS assignments to better align with the changes to the USPS Districts. The process for the USPS is still in flux, but for the NRLCA we have migrated and are getting on with business.

There are currently 656 routes in Illinois 1 and 1977 rural routes in Illinois 2, with an average volume factor of 2.27. Rural carriers assigned to these routes collectively deliver to 1,347,707

customers, while traveling over 135,615 of miles a day throughout the great state of Illinois.

972 of all the routes in Illinois are POV routes, remaining the have LLVs, or Metris' assigned. These numbers will most likely change by the publication of this article, as it is the intent of management to pursue providing a vehicle to (most) all routes..

In the last year, there have been 1058 grievances entered into our national database for the purpose of this report, with NSS Stewards attending 276 investigative interviews. These numbers derived from separate reports, an amalgamation of grievance totals by NSS level Stewards (current and recently retired grievance activities) in (old) Lakeland District, Illinois 1 and Illinois 2 within a range of dates before and after the re-organization.

There were 718 individual contractual grievances processed, the most common reasons were compensation and scheduling issues. In addition, 203 disciplinary grievances and 137 class action cases were worked on between June 1 last year and May 31 of this. These cases consist of those processed and settled at step 1 by the NSS stewards, and any case processed by Local, Area, ADR or the DR that was appealed to step 2. As of the time of writing this report for the whole of Illinois 1 and Illinois 2 districts, there are 4 open cases at step two with 24 currently open at step one. There are 2 open cases pending decision at step three, 2 at step four and one each at the Area and National arbitration level. Combined we have 68 grievances in abeyance pending the

outcome of a lead case, regarding subject matter between the National Reassessment Process phase from the year 2010 to the current issues of Unusual Conditions, the 9.2.C.3.b grievances filed for the influx of parcels due to COVID 19 and Amazon.

Both districts together within the state of Illinois currently have 76 Stewards, this includes 6 Assistant District Reps, 5 Area Stewards and the DR. We have an upcoming Local Steward Certification training expected to occur soon and enhancement trainings are expected to resume the latter half of this year. It is an honor and privilege to work with these fellow carriers who are so dedicated to advancing the rights of the Rural Craft. I am grateful for the assistance of Jessica Petty, Karen Brown, Nicole Deaton, Chelcee Owens, Sarah Erlenbusch, Janice Jensky, Vince Laino, Jonathan Morrero, Donna Beaird, Stephanie Wallace and Brian Ulrich. All our Local and Chief Stewards who are willing to represent carriers in their office and the members beyond the Steward system who work diligently to enhance the rural carrier craft.

I look forward to the future, to be working again with the membership and the Stewards in the great state of Illinois.

ILLINOIS AUXILIARY ANNUAL FINANCIAL REPORT FISCAL YEAR 2020-2021

Greetings, Everyone!

We can all agree at this point that the past couple years have proved trying at the very least. We trust that everyone finds themselves in good health with high hopes for the future, as we can see some glimpses of normalcy returning on the horizon. With the cancellation of our state convention for the second year, we have been left with very different looking financial statuses as well as agendas. Due to a binding resolution reached at National Convention in 2019, all dues monies are transferred directly to the state auxiliaries and then roughly half of those monies are then transferred by the state to the national auxiliary. Please keep this in mind when reviewing these numbers. Nearly half of all monies deposited then goes directly to the national auxiliary board for their portion of the family plan dues.

Here are the five general divisions of expenditures as set forth by our national auxiliary board. These figures are also reported to them at the end of each fiscal year.

Fiscal Year Beginning Balance as of 7-1-2020, \$16,935.41

Total Deposits, \$31,278.03 Total Expenditures, \$17,447.28

Breakdown of expenditures are as follows:

Office Supplies and Insurance, \$706.24

Board Meeting Expenses (annual officer compensation), \$1,199.00

Dues paid to National Auxiliary, \$15,542.04

Junior Expenses, \$0.00

Delegate/Convention Expense, \$0.00

Leaving the ILRLCA Auxiliary with a fiscal year-end balance of \$30,766.16 on 6-30-2021.

APCU requires us to have a savings account with a minimum of \$25 balance and due to deposits being made from NRLCA into our savings account rather than our checking account, we get some odd balances even after transferring into checking because of interest and timing, primarily, so we ended the fiscal year with a \$25.20 balance in the state auxiliary savings account.

Our board voted at our last in-person meeting to allow the Juniors to have a certain amount of petty cash on hand, which the Secretary/Treasurer of the State Auxiliary Board keeps in holding for them. This allows for cash prizes for their projects, change for fundraiser items, charity donations, etc. The Juniors end the fiscal year with a balance of petty cash in the amount of \$180. These funds are derived directly from registration fees at conventions and booster to allow them some freedom to exercise the parliamentary procedures they are learning by making motions, casting votes, etc.

As can be deduced by the facts, we are ending the year with a significant surplus but that will be helpful for

future planning of upcoming conventions, etc. Since there was such a surplus, the auxiliary decided to sponsor six \$500 scholarships to be awarded in the 2021-2022 fiscal year. Thank you for considering your Illinois Juniors worthy of a quality program where ev-

eryone is welcomed regardless of their differences. It is a wonderful program, enhanced by the many unique Juniors who participate. Here's looking to the future and hoping to see everyone at the Winter Booster or State Convention, 2022!


Judy Sharkey


Lawrence H. Pearson
